Kris Burnett stated to JB that they would submit a new application for HDC approval.

Phyllis and George Innes have erected a section of fence which is not in compliance with HDC regulations: Mrs. Innes indicated to JB that this will be removed as soon as weather permits.

#### 7:15 Public Hearing: W & F Rich, 520 Canaan St., Canaan, NH (Map #I-E, lot#9)

Abutters present: none. JoAnn Whalen, abutter, and Denise Cypher (her consultant?) participated by telephone

W & F Rich were represented by Marty Davis of Domus, Inc.

The applicant seeks approval for 12 changes to the plan which the HDC approved on May 8, 2006. Proposed changes #1-7 are indicated by number on elevations submitted with this application:

- 1. removal one of two door panels and addition of one window to the right of the door (The door will be a single door with a wooden shutter-door which can be closed and secured over the glass door when the owners are away.)
- 2. removal of two windows on the north wall of the bedroom
- 3. replacement of awning windows with shorter ones to fit between the low-headroom sloped roof and the kitchen countertop
- 4. replacement of casement window with shorter double-hung window to allow for countertop in the pantry
- 5. addition of one window to the east end of the shed
- 6. addition of a third window to the east wall of the bedroom
- 7. replacement of the door from the old summer kitchen with an awning window of the same size as the kitchen windows on the north wall

#### The following changes are not indicated numerically on the new elevations:

- 8. south elevation (sleeping porch): change from 8 windows over 4 to 8 windows over 6. (with screens in summer and glazing in winter)
- 9. north elevation: addition of another ridge line behind existing chimney, 2 vent stacks, and exhaust vents for range and dryer
- 10. north elevation: lower pitch to be 7/12;upper pitch (center section) not to exceed 9/12; all other pitches are as approved in May.
- 11. change paint color on south-east portion of house to an HDC-approved white with white trim
- 12. south elevation: retain basement windows as shown in original south elevation on the north-west section of house

Public discussion: Ms. Whalen is concerned that the result of change #2 is not aesthetically pleasing (this is the side of the building which she sees from her deck) and requests that the HDC not approve this change.

#### 8:40: Public Hearing Closed

Discussion:

Change #2: how to reach a compromise between applicants' needs and abutter's concerns: JW suggested creating the look of windows by building the frames as shown on the approved plan but filling the interior with clapboards as was done historically when windows were no longer needed or wanted.

Change #11: JB suggested that the Riches also consider painting the sleeping-porch section white to reduce the visual impact of the amount of glazing shown on south elevation. Change #8: JG suggested the use of storm-door inserts with mullions instead of glazing without grids.

Motion to accept all proposed changes with compromise suggested by JW for change #2 (creation of "faux" windows on north side of bedroom wall in location approved in May):

#### 7:05 Discussion about markers (signs) on historic homes in Canaan.

JB reiterated his opinion that encouraging residents to affix markers on historic homes be a joint project of the Canaan Historical Society and the Historic District Commission. All agree. How do we determine whether or not a home is "historic"? AM pointed out that according to the federal government's definition, a structure must be at least 50 years old. Majority of HDC members comfortable with JB's suggestion that we start with structures which are at least 100 years old.

#### Issues:

1. How to verify the age of a structure? Some towns rely on information in the assessor's office (this information is not available in Canaan for homes built before the 1923 fire which destroyed town records). Title searches only indicate owners of land, not necessarily age of a structure built on the land. 1850 map of Canaan might provide useful information. Historical society may have other ideas.

#### 2. Size and material used for the markers:

Size of the signs used in Plainfield appears to be 12x16. This allows three lines of text, followed by the date of construction. Samples from other towns vary in size and shape. Members found the Plainfield signs and the smaller signs used in Medford, MA to be attractive. Medford's signs have a logo at the top followed by *circa*, followed by date of construction. If we choose the Medford format, the Meetinghouse logo could appear at the top of the sign.

Materials: Ould Colony Artisans (company which produced the signs for Plainfield) uses ½" MDO weatherproofed signboard, primed & finished with three coats of paint. Hand-wrought iron nails are provided. A 12x16 sign costs \$55. (Other communities charge between \$70-\$175 for markers which they make available.) Merits of using markers of plastic or metal also discussed. By JB's estimate, we could probably count on at least 25 households in the Historic District to purchase signs.

#### 7:10 Discussion of Historic signs

JB and DF reported that they asked members of the Historical Society if they'd be interested in joining the HDC in an effort to encourage owners of historic homes in town to place markers on their homes indicating at least the date of construction. The Historical Society supports this endeavor.

LK shared a sample sign provided by Ould Colony Artisans of Farmington, ME, the supplier of historic signs to many New England towns, including Plainfield, NH and Medford, MA. Cost of a 12" x 16" sign is \$55 which all agree is quite reasonable given the quality of the sign. 90% of signs produced by Ould Colony are this size.

**AM** reported that Goffstown HDC made its own signs for \$35 and might be interested in producing signs for Canaan, although the cost might be higher if this is a fund-raiser for them. He also shared photos of historic markers he's seen in other communities.

**SB** volunteered to call Dimitri Gerekaris (sp?) to see if he knows someone in town who might be interested in producing signs for this project.

Much discussion ensued about whether the HDC should offer a choice of signs. One choice could be in the shape of the mock-up (rectangle with a bump-up containing image of the Meetinghouse). SB suggested that if we offer this model, that the 1761 date be placed after Canaan, New Hampshire, rather than to the right of the image of the Meetinghouse. Another choice could be the style used in Plainfield (12 x 16 rectangle) which allows for several lines of text.

**JB** offered to do a 12 x 16 mock up of what a sign for his house would look like including the information on the date and original owner of the house.

**LK** will draft a letter proposing this project to the community
