The Chair reported that there had been no response from the attorney concerning the review and revision of the District Regulations.

Consideration of Historic District signs has been deferred until November or December.

The Chair reported an issue with signs of commercial businesses located on town property on Roberts Road near its intersection with Canaan Street. After discussion the Commission took no action, leaving the issue to the Town of Canaan to address.
