Upon review of the Mark Sanbourne Conveyance Plan at Rameor Rd, Map 13, Lot 21, Claude Lemoi *Moved* and Michael Riese *Seconded the Motion* that there will be no potential regional impact should a 4-lot sub-division application be presented for this property.
